MiChildSupport Calculator

- Accessed through MiCSES
 - No additional sign-on
 - Uses same MiCSES roles and security standards
- Prepare Calculations, print results and import to OPRE
- Improve accuracy and usability
 - Only available to IV-D staff

Non-Parent Custodians

- One non-parent custodian per calculation
- Record child care expenses and medical information
- Results provided for each parent paying the non-parent custodian
 - Must check the “With Non-Parent Custodian” checkbox for each child that is with the non-parent custodian
- Custodial party’s with a custodial relationship to the child on the CASE screen

Child Care Expenses

- Record per individual child or for all children
- Child care amounts calculated per tier based on DOBs of all children
 - If a tier becomes effective after an August 31st has passed following a child's 12th birthday, that child's child care expenses will not be included for reimbursement
- Record Child and Dependent Care tax credit amounts
- Record amounts for child care subsidies or reimbursements
- Modify the parents' percentage share of the child care expenses when deviating

Recording Incomes

- Ability to record multiple sources of income for each parent
 - Helpful to get a summarized monthly total income
- Ability to record “multiple paystubs” for a source of income
 - Helpful to get an averaged monthly amount for a single source of income
- Record the source of the income information
 - For example, “quarterly wage”, “case questionnaire”
- Record potential income when a parent has the reasonable likelihood and ability to earn that income
 - When potential income is recorded for a parent, support will be calculated using actual and potential income, and again using actual income only

Functions and Features

- Missing Fields Indicator
 - Identifies fields important to the accuracy of the calculation that you may have missed
 - For example, number of additional minor children, number of people covered by health care coverage
 - Available on the Results page and data input tabs
- Edit Family Entity
 - Change non-parent custodian
 - Add children
 - Remove children added by the worker
 - Change tax year

Functions and Features...continued

- Calculation ID dropdown
 - Navigate between calculations for a docket
 - Navigate from Results page back to Parent A's Family tab
- Deviation hyperlink
 - Creates copy of current calculation and creates a “deviated from” link
 - Pop-up to fill out deviation information
 - Deviation information imported to OPRE
 - Sets “Guidelines Followed?” to “No”

Functions and Features...continued

- Ellipsis
 - Duplicate – create an exact copy of the calculation
 - Print – prints results for all payment relationships for a calculation
 - Not Provided – sets the calculation to a status to allow a worker to edit a calculation after printing
 - Archive – a status that preserves the calculation in the current state
 - Delete – deletes a calculation from view; no “undo” for deleting
 - Available in the Unattached Calculations table, or Docket Calculations table
 - Unattached Calculations table also has “Attach Calculation to Docket” function
