## DRA Overview

- Signed into law on February 8, 2006
- Became Pub. L. 109-171
- Created \$25 annual fee (FED Fee)
- Contains other changes for child support and TANF

## FED Fee Assessment

- Annual assessment
- IV-D Cases Only (case level)
  - Never TANF or FC on MHIS for CP and dependents; and
  - CP received at least \$500 in fee year

## FED Fee Assessment

- Initiating Interstate Case
- Medicaid and Food stamps
- Multiple cases

## FED Fee Options

- Michigan needs to decide:
  - Fee Year?
    - Fiscal (10/01/XX – 09/30/XX)
    - Calendar (Jan – Dec)

## **FED Fee Assessment Effective Date**

- FED Fee Effective Date-
  - Program begin date for qualifying disbursements April 1, 2008
  - Prior disbursements don't qualify
  - MiCSES auto assessment batch process began April 2008

## **April 2008 Assessment**

- Assessed roughly 56,000 IV-D cases
- Won't affect case closure
- Do not attempt to use FFEE screen
- Do not attempt to collect FED Fee

## FED Fee Collection/Retention

- Retain from CP, current and arrears
- Not from **current** food stamps
- Not from changes to current TANF
- Fee does not accrue
- MiCSES auto retention batch process with MiCSES 5.1 Release

## FED Fee Recoupment

- MiCSES has automatic and manual functionality to get the fees back from the state that have been retained in error

## CP Notification of FED Fee-Letter

- Scheduled for mailing early-mid August
- Sending to all IV-D cases:
  - No TANF/FC history on MHIS
  - Not currently “Responding” case
  - CP has good address
  - Regardless of historical collections

## CP Notification of FED Fee-Letter

- Not sending letter to:
  - Non IV-D cases
  - Cases CP requested services via a foreign country
  - IV-D cases with zero support order
  - Closed IV-D cases
  - Closed orders

- Additional communication will take place:
  - DHS Web site
  - DHS Rights and Responsibilities pamphlet
  - IVR Message
  - News, media

## BATCH\_FEDERAL\_FEE

- Assess
- Remove
- Retain collections from CP
  - Fee held 1 day (SDFF) for state fee recipient (26000FF)
- Recoup fee from State
  - Receipt type 5 created and placed on SSRE hold
  - Must be worked
- Acts only on current fee year

### View:

- Fee history by fee year
- Fee exemption status
- Fee retention exclusion reasons

## FFEE – Federal IVD Fee Screen

### Modify (Financial Supervisor role only):

- Assess a fee
- Remove a fee
- Recoup fee payments (retentions) from state
- Exempt from Assessment
- Exclude from Retention

## CPFD – CP Financial Details Report

- New section on CPFD report – after the disbursements section
- A year will only be displayed if money has been retained for that year
- The entire section will not be displayed if there has been no retention
- All events for a fee year will be reported when the fee year overlaps the date range requested for the report on the ACTS screen

## CPFD – CP Financial Details Report

### Federal Fee Activity

The federal fee is a \$25 annual fee mandated by the federal government. This fee is assessed (charged) to IV-D child support cases that have received at least \$500 in payments during the year and have never been active cash assistance (TANF, AFDC, or Tribal TANF) or food stamps. If you have a history of cash assistance (TANF, AFDC, or Tribal TANF) or food stamps, and you have been charged the fee, please provide proof of assistance to your local Friend of the Court.

The Michigan legislature has authorized the \$25 annual fee to be retained (kept) from child support payments after \$500 has been sent to you on each case. Unpaid fees from previous years will not be collected.
