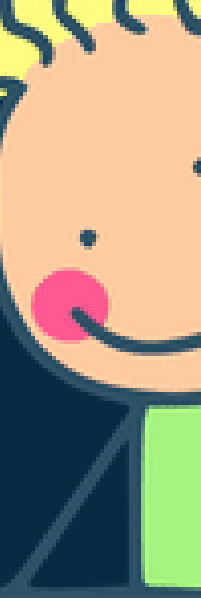

# Session Descriptions

## GOALS

### Guidance, Opportunities, Assistance, Learning, and Success

The focus of this program is to reduce or eliminate barriers to an NCP's ability to pay by referring them to job search programs such as MI Works and guiding them to programs available within the community to obtain GEDs and / or mental health and substance abuse treatments. Clients complete a questionnaire that allows the Friend of the Court to identify such barriers. Examples could be substance abuse, mental health, no driver's license, felonies, or lack of education.

### Intergov

This session will cover the basics of intergovernmental case processing. We will highlight UIFSA 2008, International Case Processing, and go over tips and tools for caseworkers who are faced with an intergovernmental case.
